Kentucky Transportation Cabinet's Stance on PTOE® Requirements

The Kentucky Transportation Center recently met with the Kentucky Secretary of Transportation to discuss Professional Traffic Operations Engineer® (PTOE) certification as a requirement of the "Advanced Traffic Engineering" prequalification for the Kentucky Transportation Cabinet's Traffic Engineering Design Services.


By presenting information showing that 31 of 50 states recognize the PTOE through either prequalifications or through the RFP process, the Kentucky Transportation Center garnered the support of the Secretary in continuing the use of the PTOE in the prequalification. There was a concession in that the prequalification will now require "the PTOE, or equivalent experience." The Secretary has left the decision up to the Division of Highway Design on how to quantify the equivalent experience. Kentucky is also able to require PTOE certification on individual projects through the RFP process.
