## **Certification News**

#### **PTOE and PTP Current Statistics**

Application and renewal rates remain strong for both the Professional Traffic Operations Engineer® (PTOE) and Professional Transportation Planner® (PTP) certification programs. With the applications received for the upcoming June PTOE exam, there have been 3,700 applications to take the exam since the program began in 1999. The overall renewal rate for PTOE certifications is 92% and the renewal rate for PTP certifications is 83%. There are currently 2,687 PTOE certificants and 333 PTP certificants.
