## **Meet the 2015 TPCB Board of Direction**

The [Transportation Professional Certification Board, Inc.](#) is a non-profit 501c3 organization and autonomous certification body affiliated with the Institute of Transportation Engineers (ITE). Board members are either elected or appointed to a 2- or 3-year term, with a new Vice Chair position implemented in 2015 to better facilitate the board's leadership transition and continuity.

ITE staff provide support for TPCB activities separately from their ITE duties, with Thomas W. Brahms serving as TPCB Executive Director and CEO. This year, the TPCB will secure a new Executive Director upon Tom's retirement at the end of 2015. Tom has served ITE for 42 years and provided 16 years of service to TPCB since its inception.

## Actions from the TPCB 2013 Survey

The TPCB board of directors thanks everyone who responded to the 2013 Survey of Current and Potential Certificants. Several actions are underway as a result of the survey, with a summary of the results available [here](#). There were three main topics identified for follow-up discussion and action based upon the survey results:

### 1. Certification Costs

The cost of taking and renewing PTOE and PTP certifications is based upon the break-even cost required to provide and maintain the certifications. The TPCB is a non-profit 501c3 organization led by a volunteer board of direction.

### 2. The Value of Certificates Versus Certifications

While often spoken about interchangeably, certificates and certifications have distinct differences. The article, "Certificate" vs. "Certification" By Adam Andrews, CIEC , available [here](#), provides an overview of these differences. More information on this topic will be provided in terms of the TPCB certification programs in upcoming TPCB newsletter articles.

### 3. Safety Certification

Nearly 80 percent of the survey respondents indicated interest in obtaining certification in transportation safety. The TPCB Board of Direction has taken action to pursue safety certification development as a result.

## ITE Receives Approval as Continuing Professional Development Sponsor/Provider by LAPELS

On January 26, 2015, ITE was approved as a continuing professional development sponsor/provider by the Louisiana Board of Professional Engineers and Land Surveyors (LAPELS). Engineers in Louisiana can review the LAPELS website for a list of ITE courses that provide PDHs which will most likely be accepted for state P.E. license renewal. The Louisiana Professional Engineers and Surveying Board is currently renewing firms, individual professional licenses, and intern certifications with licenses scheduled to expire on March 31, 2015.

## RFPs Requiring PTOE and PTP Certification

PTOE and PTP certifications may not only provide an edge for request for proposal (RFP) respondents; these certifications may be required for interested firms to apply. For example:

The Town of Comox, British Columbia, USA includes a qualification requirement in its requests for proposals (RFPs) that states, "As a minimum the project is to be led by a professional engineer who is also certified as a professional transportation operating engineer."
